

Premium Fiberglass Pools Privacy Policy

This Privacy Policy describes our policies and procedures on the collection, use, and disclosure of your information when you use the Service and explains your privacy rights and how the law protects you.

We use your personal data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this Privacy Policy.

Interpretation and Definitions

Interpretation

Words with initial capital letters have meanings defined under the following conditions. The definitions shall have the same meaning regardless of whether they appear in singular or plural.

Definitions

For the purposes of this Privacy Policy:

Account means a unique account created for you to access our Service or parts of our Service.

Affiliate means an entity that controls, is controlled by, or is under common control with a party, where “control” means ownership of 50% or more of the shares, equity interest, or other securities entitled to vote for election of directors or other managing authority.

Company (referred to as either “the Company,” “We,” “Us,” or “Our” in this Agreement) refers to **Premium Fiberglass Pools LLC**, 6190 45th St N, Saint Petersburg, FL 33714.

Cookies are small files placed on your computer, mobile device, or any other device by a website, containing details of your browsing history among its many uses.

Country refers to: **Florida, United States.**

Device means any device that can access the Service such as a computer, cellphone, or tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Website.

Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, provide the Service on behalf of the Company, perform Service-related activities, or assist the Company in analyzing how the Service is used.

Types of Data Collected

Personal Data

Usage Data

- **Cookies Policy / Notice Acceptance Cookies** (Persistent) – remember your cookie preferences.
- **Functionality Cookies** (Persistent) – remember choices like login or language.

You can instruct your browser to refuse all cookies, but some parts of the Service may not function properly without them.

Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- To provide and maintain our Service.
- To manage your account and access to Service features.
- To perform a contract for products or services you've purchased.
- To contact you by email, phone, SMS, or other means for service-related updates or marketing (as allowed).
